
NOTE. Although the American Community Survey (ACS) produces population, demographic and housing unit estimates, it is the Census Bureau's Population Estimates Program that produces and disseminates the official estimates of the population for the nation, states, counties, cities and towns and estimates of housing units for states and counties.

HOUSEHOLDS AND FAMILIES: In 2005-2009 there were 2,500 households in Allegany town. The average household size was 2.4 people.

Families made up 66 percent of the households in Allegany town. This figure includes both married-couple families (53 percent) and other families (13 percent). Nonfamily households made up 34 percent of all households in Allegany town. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.

### The Types of Households in Allegany town, Cattaraugus County, New York in 2005-2009





NATIVITY AND LANGUAGE: Three percent of the people living in Allegany town in 2005-2009 were foreign born. Ninety-seven percent was native, including 75 percent who were born in New York.

Among people at least five years old living in Allegany town in 2005-2009, 6 percent spoke a language other than English at home. Of those speaking a language other than English at home, 48 percent spoke Spanish and 52 percent spoke some other language; 24 percent reported that they did not speak English "very well."

GEOGRAPHIC MOBILITY: In 2005-2009, 79 percent of the people at least one year old living in Allegany town were living in the same residence one year earlier; 7 percent had moved during the past year from another residence in the same county, 9 percent from another county in the same state, 5 percent from another state, and less than 0.5 percent from abroad.

Geographic Mobility of Residents of Allegany town, Cattaraugus County, New York in 2005-2009



EDUCATION: In 2005-2009, 92 percent of people 25 years and over had at least graduated from high school and 26 percent had a bachelor's degree or higher. Eight percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Allegany town was 3,500 in 2005-2009. Nursery school and kindergarten enrollment was 240 and elementary or high school enrollment was 860 children. College or graduate school enrollment was 2,400.

### The Educational Attainment of People in Allegany town, Cattaraugus County, New York in 2005-2009






DISABILITY: In Allegany town, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2005-2009, for the employed population 16 years and older, the leading industries in Allegany town were Educational services, and health care, and social assistance, 30 percent, and Retail trade, 15 percent.


OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Management, professional, and related occupations, 33 percent; Sales and office occupations, 29 percent; Service occupations, 17 percent; Production, transportation, and material moving occupations, 12 percent; and Construction, extraction, maintenance, and repair occupations, 8 percent. Eighty percent of the people employed were Private wage and salary workers; 15 percent was Federal, state, or local government workers; and 5 percent was Self-employed in own not incorporated business workers.

TRAVEL TO WORK: Seventy-eight percent of Allegany town workers drove to work alone in 2005-2009, 10 percent carpooled, 1 percent took public transportation, and 9 percent used other means. The remaining 2 percent worked at home. Among those who commuted to work, it took them on average 15.5 minutes to get to work.

INCOME: The median income of households in Allegany town was \$49,350. Seventy-eight percent of the households received earnings and 23 percent received retirement income other than Social Security. Thirty-one percent of the households received Social Security. The average income from Social Security was \$16,588. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2005-2009, 14 percent of people were in poverty. Sixteen percent of related children under 18 were below the poverty level, compared with 8 percent of people 65 years old and over. Seven percent of all families and 20 percent of families with a female householder and no husband present had incomes below the poverty level.


#### Poverty Rates in Allegany town, Cattaraugus County, New York in 2005-2009

POPULATION OF Allegany town: In 2005-2009, Allegany town had a total population of 8,000 - 4,100 (52 percent) females and 3,900 (48 percent) males. The median age was 26.2 years. Seventeen percent of the population was under 18 years and 12 percent was 65 years and older.

The Age Distribution of People in Allegany town, Cattaraugus County, New York in 2005-2009



For people reporting one race alone, 95 percent was White; 2 percent was Black or African American; less than 0.5 percent was American Indian and Alaska Native; 1 percent was Asian; less than 0.5 percent was Native Hawaiian and Other Pacific Islander, and 1 percent was Some other race. One percent reported Two or more races. Two percent of the people in Allegany town was Hispanic. Ninety-five percent of the people in Allegany town was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Allegany town had a total of 2,700 housing units, 8 percent of which were vacant. Of the total housing units, 63 percent was in single-unit structures, 15 percent was in multi-unit structures, and 22 percent was mobile homes. Twenty percent of the housing units were built since 1990.

The Types of Housing Units in Allegany town, Cattaraugus County, New York in 2005-2009





OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Allegany town had 2,500 occupied housing units - 1,800 (74 percent) owner occupied and 630 (26 percent) renter occupied. Six percent of the households did not have telephone service and 6 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Forty-four percent had two vehicles and another 14 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$1,147, nonmortgaged owners \$465, and renters \$636. Twenty-one percent of owners with mortgages, 17 percent of owners without mortgages, and 45 percent of renters in Allegany town spent 30 percent or more of household income on housing.
