
NOTE. Although the American Community Survey (ACS) produces population, demographic and housing unit estimates, it is the Census Bureau's Population Estimates Program that produces and disseminates the official estimates of the population for the nation, states, counties, cities and towns and estimates of housing units for states and counties.

HOUSEHOLDS AND FAMILIES: In 2005-2009 there were 510 households in Carrollton town. The average household size was 2.3 people.

Families made up 65 percent of the households in Carrollton town. This figure includes both married-couple families (52 percent) and other families (12 percent). Nonfamily households made up 35 percent of all households in Carrollton town. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.

### The Types of Households in Carrollton town, Cattaraugus County, New York in 2005-2009





NATIVITY AND LANGUAGE: Less than 0.5 percent of the people living in Carrollton town in 2005-2009 were foreign born. One hundred percent was native, including 50 percent who were born in New York.

Among people at least five years old living in Carrollton town in 2005-2009, 3 percent spoke a language other than English at home. Of those speaking a language other than English at home, 79 percent spoke Spanish and 21 percent spoke some other language; 29 percent reported that they did not speak English "very well."

GEOGRAPHIC MOBILITY: In 2005-2009, 88 percent of the people at least one year old living in Carrollton town were living in the same residence one year earlier; 5 percent had moved during the past year from another residence in the same county, 5 percent from another county in the same state, 1 percent from another state, and less than 0.5 percent from abroad.

Geographic Mobility of Residents of Carrollton town, Cattaraugus County, New York in 2005-2009



EDUCATION: In 2005-2009, 87 percent of people 25 years and over had at least graduated from high school and 14 percent had a bachelor's degree or higher. Thirteen percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Carrollton town was 330 in 2005-2009. Nursery school and kindergarten enrollment was 26 and elementary or high school enrollment was 280 children. College or graduate school enrollment was 20.

The Educational Attainment of People in Carrollton town, Cattaraugus County, New York in 2005-2009






DISABILITY: In Carrollton town, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2005-2009, for the employed population 16 years and older, the leading industries in Carrollton town were Educational services, and health care, and social assistance, 24 percent, and Manufacturing, 21 percent.


OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Production, transportation, and material moving occupations, 25 percent; Sales and office occupations, 24 percent; Management, professional, and related occupations, 23 percent; Service occupations, 19 percent; and Construction, extraction, maintenance, and repair occupations, 10 percent. Seventy-four percent of the people employed were Private wage and salary workers; 19 percent was Federal, state, or local government workers; and 6 percent was Self-employed in own not incorporated business workers.

TRAVEL TO WORK: Eighty-two percent of Carrollton town workers drove to work alone in 2005-2009, 14 percent carpooled, 1 percent took public transportation, and 1 percent used other means. The remaining 2 percent worked at home. Among those who commuted to work, it took them on average 23.7 minutes to get to work.

INCOME: The median income of households in Carrollton town was \$39,886. Sixty-nine percent of the households received earnings and 23 percent received retirement income other than Social Security. Thirty-nine percent of the households received Social Security. The average income from Social Security was \$15,828. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2005-2009, 18 percent of people were in poverty. Twenty-eight percent of related children under 18 were below the poverty level, compared with 15 percent of people 65 years old and over. Nine percent of all families and 11 percent of families with a female householder and no husband present had incomes below the poverty level.

#### Poverty Rates in Carrollton town, Cattaraugus County, New York in 2005-2009




### Percent below poverty level

POPULATION OF Carrollton town: In 2005-2009, Carrollton town had a total population of 1,200 - 580 (47 percent) females and 650 (53 percent) males. The median age was 41.9 years. Twenty-six percent of the population was under 18 years and 19 percent was 65 years and older.

The Age Distribution of People in Carrollton town, Cattaraugus County, New York in 2005-2009



For people reporting one race alone, 93 percent was White; 4 percent was Black or African American; 1 percent was American Indian and Alaska Native; less than 0.5 percent was Asian; less than 0.5 percent was Native Hawaiian and Other Pacific Islander, and less than 0.5 percent was Some other race. One percent reported Two or more races. Six percent of the people in Carrollton town was Hispanic. Eighty-eight percent of the people in Carrollton town was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Carrollton town had a total of 630 housing units, 19 percent of which were vacant. Of the total housing units, 71 percent was in single-unit structures, 7 percent was in multi-unit structures, and 22 percent was mobile homes. Eighteen percent of the housing units were built since 1990.


OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Carrollton town had 510 occupied housing units - 420 (82 percent) owner occupied and 93 (18 percent) renter occupied. Three percent of the households did not have telephone service and 7 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Forty-one percent had two vehicles and another 19 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$853, nonmortgaged owners \$382, and renters \$391. Twenty percent of owners with mortgages, 16 percent of owners without mortgages, and 59 percent of renters in Carrollton town spent 30 percent or more of household income on housing.
