

NOTE. HOUSEHOLDS AND FAMILIES: In 2005-2009 there were 740 households in Dayton town. The average household size was 2.7 people.

Families made up 70 percent of the households in Dayton town. This figure includes both marriedcouple families (52 percent) and other families (18 percent). Nonfamily households made up 30 percent of all households in Dayton town. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.

NATIVITY AND LANGUAGE: One percent of the people living in Dayton town in 2005-2009 were foreign born. Ninety-nine percent was native, including 83 percent who were born in New York.

Among people at least five years old living in Dayton town in 2005-2009, 4 percent spoke a language other than English at home. Of those speaking a language other than English at home, 49 percent spoke Spanish and 51 percent spoke some other language; 31 percent reported that they did not speak English "very well."

GEOGRAPHIC MOBILITY: In 2005-2009, 92 percent of the people at least one year old living in Dayton town were living in the same residence one year earlier; 4 percent had moved during the past year from another residence in the same county, 3 percent from another county in the same state, 1 percent from another state, and less than 0.5 percent from abroad.



EDUCATION: In 2005-2009, 85 percent of people 25 years and over had at least graduated from high school and 12 percent had a bachelor's degree or higher. Fifteen percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Dayton town was 520 in 2005-2009. Nursery school and kindergarten enrollment was 40 and elementary or high school enrollment was 440 children. College or graduate school enrollment was 44.




The Educational Attainment of People in Dayton town, Cattaraugus County, New York in 2005-2009



DISABILITY: In Dayton town, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2005-2009, for the employed population 16 years and older, the leading industries in Dayton town were Educational services, and health care, and social assistance, 21 percent, and Public administration, 18 percent.

Employment by Industry in Dayton town, Cattaraugus County, New York in 2005-2009






OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Service occupations, 25 percent; Sales and office occupations, 23 percent; Production, transportation, and material moving occupations, 21 percent; Management, professional, and related occupations, 19 percent; and Construction, extraction, maintenance, and repair occupations, 13 percent. Sixty-three percent of the people employed were Private wage and salary workers; 33 percent was Federal, state, or local government workers; and 4 percent was Self-employed in own not incorporated business workers.

TRAVEL TO WORK: Eighty-two percent of Dayton town workers drove to work alone in 2005-2009, 11 percent carpooled, less than 0.5 percent took public transportation, and 6 percent used other means. The remaining 2 percent worked at home. Among those who commuted to work, it took them on average 26.5 minutes to get to work.

INCOME: The median income of households in Dayton town was \$47,500. Seventy-three percent of the households received earnings and 23 percent received retirement income other than Social Security. Thirty-eight percent of the households received Social Security. The average income from Social Security was \$15,770. These income sources are not mutually exclusive; that is, some households received income from more than one source.


POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2005-2009, 13 percent of people were in poverty. Seven percent of related children under 18 were below the poverty level, compared with 14 percent of people 65 years old and over. Six percent of all families and 14 percent of families with a female householder and no husband present had incomes below the poverty level.

POPULATION OF Dayton town: In 2005-2009, Dayton town had a total population of 2,000 - 1000 (51 percent) females and 960 (49 percent) males. The median age was 42.5 years. Twenty-seven percent of the population was under 18 years and 15 percent was 65 years and older.


The Age Distribution of People in Dayton town, Cattaraugus County, New York in 2005-2009

For people reporting one race alone, 97 percent was White; less than 0.5 percent was Black or African American; less than 0.5 percent was American Indian and Alaska Native; less than 0.5 percent was Asian; less than 0.5 percent was Native Hawaiian and Other Pacific Islander, and less than 0.5 percent was Some other race. Three percent reported Two or more races. One percent of the people in Dayton town was Hispanic. Ninety-seven percent of the people in Dayton town was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Dayton town had a total of 860 housing units, 14 percent of which were vacant. Of the total housing units, 81 percent was in single-unit structures, 8 percent was in multi-unit structures, and 11 percent was mobile homes. Seven percent of the housing units were built since 1990.




The Types of Housing Units in Dayton town, Cattaraugus County, New York in 2005-2009

OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Dayton town had 740 occupied housing units - 580 (79 percent) owner occupied and 160 (21 percent) renter occupied. Three percent of the households did not have telephone service and 8 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Thirty-nine percent had two vehicles and another 22 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$991, nonmortgaged owners \$436, and renters \$607. Fifteen percent of owners with mortgages, 19 percent of owners without mortgages, and 58 percent of renters in Dayton town spent 30 percent or more of household income on housing.
