
NOTE. Although the American Community Survey (ACS) produces population, demographic and housing unit estimates, it is the Census Bureau's Population Estimates Program that produces and disseminates the official estimates of the population for the nation, states, counties, cities and towns and estimates of housing units for states and counties.

HOUSEHOLDS AND FAMILIES: In 2005-2009 there were 760 households in Ellicottville town. The average household size was 2.1 people.

Families made up 57 percent of the households in Ellicottville town. This figure includes both married-couple families (46 percent) and other families (11 percent). Nonfamily households made up 43 percent of all households in Ellicottville town. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.

The Types of Households in Ellicottville town, Cattaraugus County, New York in 2005-2009





NATIVITY AND LANGUAGE: Five percent of the people living in Ellicottville town in 2005-2009 were foreign born. Ninety-five percent was native, including 76 percent who were born in New York.

Among people at least five years old living in Ellicottville town in 2005-2009, 3 percent spoke a language other than English at home. Of those speaking a language other than English at home, 33 percent spoke Spanish and 67 percent spoke some other language; 18 percent reported that they did not speak English "very well."

GEOGRAPHIC MOBILITY: In 2005-2009, 91 percent of the people at least one year old living in Ellicottville town were living in the same residence one year earlier; 4 percent had moved during the past year from another residence in the same county, 1 percent from another county in the same state, 3 percent from another state, and less than 0.5 percent from abroad.

Geographic Mobility of Residents of Ellicottville town, Cattaraugus County, New York in 2005-2009



EDUCATION: In 2005-2009, 93 percent of people 25 years and over had at least graduated from high school and 30 percent had a bachelor's degree or higher. Seven percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Ellicottville town was 380 in 2005-2009. Nursery school and kindergarten enrollment was 53 and elementary or high school enrollment was 250 children. College or graduate school enrollment was 79.

The Educational Attainment of People in Ellicottville town, Cattaraugus County, New York in 2005-2009






DISABILITY: In Ellicottville town, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2005-2009, for the employed population 16 years and older, the leading industries in Ellicottville town were Arts, entertainment, and recreation, and accommodation and food services, 25 percent, and Educational services, and health care, and social assistance, 18 percent.


OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Management, professional, and related occupations, 33 percent; Sales and office occupations, 21 percent; Service occupations, 20 percent; Production, transportation, and material moving occupations, 15 percent; and Construction, extraction, maintenance, and repair occupations, 10 percent. Sixty-seven percent of the people employed were Private wage and salary workers; 24 percent was Federal, state, or local government workers; and 10 percent was Self-employed in own not incorporated business workers.

TRAVEL TO WORK: Seventy-nine percent of Ellicottville town workers drove to work alone in 2005-2009, 5 percent carpooled, less than 0.5 percent took public transportation, and 10 percent used other means. The remaining 5 percent worked at home. Among those who commuted to work, it took them on average 24.6 minutes to get to work.

INCOME: The median income of households in Ellicottville town was \$44,028. Eighty-one percent of the households received earnings and 18 percent received retirement income other than Social Security. Thirty-four percent of the households received Social Security. The average income from Social Security was \$14,033. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2005-2009, 8 percent of people were in poverty. Eleven percent of related children under 18 were below the poverty level, compared with 9 percent of people 65 years old and over. Six percent of all families and 60 percent of families with a female householder and no husband present had incomes below the poverty level.


Poverty Rates in Ellicottville town, Cattaraugus County, New York in 2005-2009

POPULATION OF Ellicottville town: In 2005-2009, Ellicottville town had a total population of 1,600 - 830 (51 percent) females and 780 (49 percent) males. The median age was 45.7 years. Twenty-two percent of the population was under 18 years and 17 percent was 65 years and older.

The Age Distribution of People in Ellicottville town, Cattaraugus County, New York in 2005-2009



For people reporting one race alone, 100 percent was White; less than 0.5 percent was Black or African American; less than 0.5 percent was American Indian and Alaska Native; less than 0.5 percent was Asian; less than 0.5 percent was Native Hawaiian and Other Pacific Islander, and less than 0.5 percent was Some other race. Less than 0.5 percent reported Two or more races. One percent of the people in Ellicottville town was Hispanic. Ninety-nine percent of the people in Ellicottville town was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Ellicottville town had a total of 2,100 housing units, 64 percent of which were vacant. Of the total housing units, 59 percent was in single-unit structures, 36 percent was in multi-unit structures, and 5 percent was mobile homes. Seventeen percent of the housing units were built since 1990.

The Types of Housing Units in Ellicottville town, Cattaraugus County, New York in 2005-2009





OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Ellicottville town had 760 occupied housing units - 530 (69 percent) owner occupied and 230 (31 percent) renter occupied. Three percent of the households did not have telephone service and 6 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Forty percent had two vehicles and another 11 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$1,470, nonmortgaged owners \$594, and renters \$568. Thirty-seven percent of owners with mortgages, 13 percent of owners without mortgages, and 36 percent of renters in Ellicottville town spent 30 percent or more of household income on housing.
