
NOTE. HOUSEHOLDS AND FAMILIES: In 2005-2009 there were 1,200 households in Gowanda village. The average household size was 2.2 people.

Families made up 64 percent of the households in Gowanda village. This figure includes both married-couple families (48 percent) and other families (16 percent). Nonfamily households made up 36 percent of all households in Gowanda village. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.


NATIVITY AND LANGUAGE: One percent of the people living in Gowanda village in 2005-2009 were foreign born. Ninety-nine percent was native, including 83 percent who were born in New York.

Among people at least five years old living in Gowanda village in 2005-2009, 4 percent spoke a language other than English at home. Of those speaking a language other than English at home, 18 percent spoke Spanish and 82 percent spoke some other language; 5 percent reported that they did not speak English "very well."

GEOGRAPHIC MOBILITY: In 2005-2009, 84 percent of the people at least one year old living in Gowanda village were living in the same residence one year earlier; 11 percent had moved during the past year from another residence in the same county, 5 percent from another county in the same state, less than 0.5 percent from another state, and less than 0.5 percent from abroad.



EDUCATION: In 2005-2009, 88 percent of people 25 years and over had at least graduated from high school and 21 percent had a bachelor's degree or higher. Twelve percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Gowanda village was 580 in 2005-2009. Nursery school and kindergarten enrollment was 31 and elementary or high school enrollment was 490 children. College or graduate school enrollment was 58.

The Educational Attainment of People in Gowanda village, New York in 2005-2009




DISABILITY: In Gowanda village, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2005-2009, for the employed population 16 years and older, the leading industries in Gowanda village were Educational services, and health care, and social assistance, 36 percent, and Public administration, 11 percent.


OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Service occupations, 35 percent; Management, professional, and related occupations, 25 percent; Sales and office occupations, 17 percent; Production, transportation, and material moving occupations, 13 percent; and Construction, extraction, maintenance, and repair occupations, 8 percent. Sixty-four percent of the people employed were Private wage and salary workers; 31 percent was Federal, state, or local government workers; and 5 percent was Self-employed in own not incorporated business workers.

TRAVEL TO WORK: Seventy-one percent of Gowanda village workers drove to work alone in 2005-2009, 7 percent carpooled, 1 percent took public transportation, and 15 percent used other means. The remaining 6 percent worked at home. Among those who commuted to work, it took them on average 24.5 minutes to get to work.

INCOME: The median income of households in Gowanda village was \$43,889. Seventy-nine percent of the households received earnings and 23 percent received retirement income other than Social Security. Twenty-eight percent of the households received Social Security. The average income from Social Security was \$16,911. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2005-2009, 13 percent of people were in poverty. Eleven percent of related children under 18 were below the poverty level, compared with 11 percent of people 65 years old and over. Six percent of all families and 20 percent of families with a female householder and no husband present had incomes below the poverty level.


Poverty Rates in Gowanda village, New York in 2005-2009

POPULATION OF Gowanda village: In 2005-2009, Gowanda village had a total population of 2,900 - 1,600 (55 percent) females and 1,300 (45 percent) males. The median age was 43.8 years. Twenty percent of the population was under 18 years and 15 percent was 65 years and older.

The Age Distribution of People in Gowanda village, New York in 2005-2009



For people reporting one race alone, 93 percent was White; 1 percent was Black or African American; 3 percent was American Indian and Alaska Native; less than 0.5 percent was Asian; less than 0.5 percent was Native Hawaiian and Other Pacific Islander, and less than 0.5 percent was Some other race. Four percent reported Two or more races. Two percent of the people in Gowanda village was Hispanic. Ninety-one percent of the people in Gowanda village was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Gowanda village had a total of 1,300 housing units, 3 percent of which were vacant. Of the total housing units, 67 percent was in single-unit structures, 32 percent was in multi-unit structures, and 1 percent was mobile homes. Two percent of the housing units were built since 1990.

The Types of Housing Units in Gowanda village, New York in 2005-2009





OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Gowanda village had 1,200 occupied housing units - 850 (68 percent) owner occupied and 400 (32 percent) renter occupied. Four percent of the households did not have telephone service and 5 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Forty-two percent had two vehicles and another 9 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$1,086, nonmortgaged owners \$460, and renters \$573. Twenty-nine percent of owners with mortgages, 13 percent of owners without mortgages, and 47 percent of renters in Gowanda village spent 30 percent or more of household income on housing.
