

NOTE. HOUSEHOLDS AND FAMILIES: In 2005-2009 there were 820 households in Hinsdale town. The average household size was 2.3 people.

Families made up 64 percent of the households in Hinsdale town. This figure includes both marriedcouple families (50 percent) and other families (14 percent). Nonfamily households made up 36 percent of all households in Hinsdale town. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.



The Types of Households in Hinsdale town, Cattaraugus County, New York in 2005-2009



NATIVITY AND LANGUAGE: Less than 0.5 percent of the people living in Hinsdale town in 2005-2009 were foreign born. One hundred percent was native, including 82 percent who were born in New York.

Among people at least five years old living in Hinsdale town in 2005-2009, 4 percent spoke a language other than English at home. Of those speaking a language other than English at home, less than 0.5 percent spoke Spanish and 100 percent spoke some other language; less than 0.5 percent reported that they did not speak English "very well."

GEOGRAPHIC MOBILITY: In 2005-2009, 97 percent of the people at least one year old living in Hinsdale town were living in the same residence one year earlier; 1 percent had moved during the past year from another residence in the same county, 2 percent from another county in the same state, less than 0.5 percent from another state, and less than 0.5 percent from abroad.

Geographic Mobility of Residents of Hinsdale town, Cattaraugus County, New York in 2005-2009



EDUCATION: In 2005-2009, 85 percent of people 25 years and over had at least graduated from high school and 12 percent had a bachelor's degree or higher. Fifteen percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Hinsdale town was 380 in 2005-2009. Nursery school and kindergarten enrollment was 40 and elementary or high school enrollment was 300 children. College or graduate school enrollment was 38.

The Educational Attainment of People in Hinsdale town, Cattaraugus County, New York in 2005-2009




Percent of people 25 years and over



DISABILITY: In Hinsdale town, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2005-2009, for the employed population 16 years and older, the leading industries in Hinsdale town were Educational services, and health care, and social assistance, 21 percent, and Manufacturing, 21 percent.


OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Sales and office occupations, 26 percent; Production, transportation, and material moving occupations, 22 percent; Service occupations, 21 percent; Management, professional, and related occupations, 15 percent; and Construction, extraction, maintenance, and repair occupations, 14 percent. Eighty-three percent of the people employed were Private wage and salary workers; 16 percent was Federal, state, or local government workers; and 1 percent was Self-employed in own not incorporated business workers.

TRAVEL TO WORK: Eighty-three percent of Hinsdale town workers drove to work alone in 2005-2009, 14 percent carpooled, 2 percent took public transportation, and less than 0.5 percent used other means. The remaining less than 0.5 percent worked at home. Among those who commuted to work, it took them on average 22.2 minutes to get to work.

INCOME: The median income of households in Hinsdale town was \$40,709. Seventy-two percent of the households received earnings and 26 percent received retirement income other than Social Security. Thirty-nine percent of the households received Social Security. The average income from Social Security was \$13,673. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2005-2009, 17 percent of people were in poverty. Thirty-five percent of related children under 18 were below the poverty level, compared with 8 percent of people 65 years old and over. Fourteen percent of all families and 55 percent of families with a female householder and no husband present had incomes below the poverty level.



POPULATION OF Hinsdale town: In 2005-2009, Hinsdale town had a total population of 1,900 - 910 (48 percent) females and 970 (52 percent) males. The median age was 48.1 years. Twenty-four percent of the population was under 18 years and 17 percent was 65 years and older.


The Age Distribution of People in Hinsdale town, Cattaraugus County, New York in 2005-2009

For people reporting one race alone, 100 percent was White; less than 0.5 percent was Black or African American; less than 0.5 percent was American Indian and Alaska Native; less than 0.5 percent was Asian; less than 0.5 percent was Native Hawaiian and Other Pacific Islander, and less than 0.5 percent was Some other race. Less than 0.5 percent reported Two or more races. Less than 0.5 percent of the people in Hinsdale town was Hispanic. One hundred percent of the people in Hinsdale town was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Hinsdale town had a total of 1,200 housing units, 29 percent of which were vacant. Of the total housing units, 61 percent was in single-unit structures, 1 percent was in multi-unit structures, and 39 percent was mobile homes. Twenty-three percent of the housing units were built since 1990.




The Types of Housing Units in Hinsdale town, Cattaraugus County, New York in 2005-2009

OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Hinsdale town had 820 occupied housing units - 720 (88 percent) owner occupied and 100 (12 percent) renter occupied. Eleven percent of the households did not have telephone service and 6 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Forty-three percent had two vehicles and another 15 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$1,021, nonmortgaged owners \$391, and renters \$675. Forty percent of owners with mortgages, 23 percent of owners without mortgages, and 33 percent of renters in Hinsdale town spent 30 percent or more of household income on housing.
