
NOTE. HOUSEHOLDS AND FAMILIES: In 2005-2009 there were 160 households in Limestone village. The average household size was 2 people.

Families made up 53 percent of the households in Limestone village. This figure includes both married-couple families (44 percent) and other families (9 percent). Nonfamily households made up 47 percent of all households in Limestone village. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.


NATIVITY AND LANGUAGE: Less than 0.5 percent of the people living in Limestone village in 2005-2009 were foreign born. One hundred percent was native, including 47 percent who were born in New York.

Among people at least five years old living in Limestone village in 2005-2009, 2 percent spoke a language other than English at home. Of those speaking a language other than English at home, less than 0.5 percent spoke Spanish and 100 percent spoke some other language; 20 percent reported that they did not speak English "very well."

GEOGRAPHIC MOBILITY: In 2005-2009, 89 percent of the people at least one year old living in Limestone village were living in the same residence one year earlier; 8 percent had moved during the past year from another residence in the same county, less than 0.5 percent from another county in the same state, 3 percent from another state, and less than 0.5 percent from abroad.



EDUCATION: In 2005-2009, 88 percent of people 25 years and over had at least graduated from high school and 14 percent had a bachelor's degree or higher. Twelve percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Limestone village was 64 in 2005-2009. Nursery school and kindergarten enrollment was 4 and elementary or high school enrollment was 60 children. College or graduate school enrollment was less than 0.5.

The Educational Attainment of People in Limestone village, New York in 2005-2009




DISABILITY: In Limestone village, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2005-2009, for the employed population 16 years and older, the leading industries in Limestone village were Educational services, and health care, and social assistance, 22 percent, and Manufacturing, 20 percent.


OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Sales and office occupations, 28 percent; Management, professional, and related occupations, 22 percent; Service occupations, 18 percent; Production, transportation, and material moving occupations, 18 percent; and Construction, extraction, maintenance, and repair occupations, 13 percent. Eighty percent of the people employed were Private wage and salary workers; 16 percent was Federal, state, or local government workers; and 4 percent was Self-employed in own not incorporated business workers.

TRAVEL TO WORK: Seventy-eight percent of Limestone village workers drove to work alone in 2005-2009, 15 percent carpooled, less than 0.5 percent took public transportation, and 3 percent used other means. The remaining 3 percent worked at home. Among those who commuted to work, it took them on average 18.8 minutes to get to work.

INCOME: The median income of households in Limestone village was \$33,854. Sixty-one percent of the households received earnings and 23 percent received retirement income other than Social Security. Forty-eight percent of the households received Social Security. The average income from Social Security was \$10,638. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2005-2009, 13 percent of people were in poverty. Eight percent of related children under 18 were below the poverty level, compared with 21 percent of people 65 years old and over. Seven percent of all families and 40 percent of families with a female householder and no husband present had incomes below the poverty level.


Poverty Rates in Limestone village, New York in 2005-2009

POPULATION OF Limestone village: In 2005-2009, Limestone village had a total population of 310 - 170 (55 percent) females and 140 (45 percent) males. The median age was 49.2 years. Twenty-two percent of the population was under 18 years and 21 percent was 65 years and older.

The Age Distribution of People in Limestone village, New York in 2005-2009



For people reporting one race alone, 100 percent was White; less than 0.5 percent was Black or African American; less than 0.5 percent was American Indian and Alaska Native; less than 0.5 percent was Asian; less than 0.5 percent was Native Hawaiian and Other Pacific Islander, and less than 0.5 percent was Some other race. Less than 0.5 percent reported Two or more races. Less than 0.5 percent of the people in Limestone village was Hispanic. One hundred percent of the people in Limestone village was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Limestone village had a total of 170 housing units, 5 percent of which were vacant. Of the total housing units, 60 percent was in single-unit structures, 21 percent was in multi-unit structures, and 18 percent was mobile homes. Twenty-one percent of the housing units were built since 1990.


OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Limestone village had 160 occupied housing units - 110 (67 percent) owner occupied and 52 (33 percent) renter occupied. Three percent of the households did not have telephone service and 16 percent of the households did not have access to a car, truck, or van for private use. Thirty-eight percent had two vehicles and another 10 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$831, nonmortgaged owners \$405, and renters \$313. Eleven percent of owners with mortgages, 52 percent of owners without mortgages, and 67 percent of renters in Limestone village spent 30 percent or more of household income on housing.
