

NOTE. HOUSEHOLDS AND FAMILIES: In 2005-2009 there were 740 households in Little Valley town. The average household size was 2.1 people.

Families made up 64 percent of the households in Little Valley town. This figure includes both married-couple families (50 percent) and other families (14 percent). Nonfamily households made up 36 percent of all households in Little Valley town. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.

NATIVITY AND LANGUAGE: One percent of the people living in Little Valley town in 2005-2009 were foreign born. Ninety-nine percent was native, including 83 percent who were born in New York.

Among people at least five years old living in Little Valley town in 2005-2009, 2 percent spoke a language other than English at home. Of those speaking a language other than English at home, 21 percent spoke Spanish and 79 percent spoke some other language; 21 percent reported that they did not speak English "very well."

GEOGRAPHIC MOBILITY: In 2005-2009, 79 percent of the people at least one year old living in Little Valley town were living in the same residence one year earlier; 14 percent had moved during the past year from another residence in the same county, 5 percent from another county in the same state, 3 percent from another state, and less than 0.5 percent from abroad.

Geographic Mobility of Residents of Little Valley town, Cattaraugus County, New York in 2005-2009





EDUCATION: In 2005-2009, 86 percent of people 25 years and over had at least graduated from high school and 11 percent had a bachelor's degree or higher. Fourteen percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Little Valley town was 320 in 2005-2009. Nursery school and kindergarten enrollment was 37 and elementary or high school enrollment was 220 children. College or graduate school enrollment was 64.






Percent of people 25 years and over



DISABILITY: In Little Valley town, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2005-2009, for the employed population 16 years and older, the leading industries in Little Valley town were Educational services, and health care, and social assistance, 19 percent, and Manufacturing, 12 percent.


OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Sales and office occupations, 25 percent; Service occupations, 24 percent; Management, professional, and related occupations, 23 percent; Construction, extraction, maintenance, and repair occupations, 14 percent; and Production, transportation, and material moving occupations, 13 percent. Sixty-two percent of the people employed were Private wage and salary workers; 31 percent was Federal, state, or local government workers; and 7 percent was Self-employed in own not incorporated business workers.

TRAVEL TO WORK: Eighty-five percent of Little Valley town workers drove to work alone in 2005-2009, 9 percent carpooled, less than 0.5 percent took public transportation, and 3 percent used other means. The remaining 3 percent worked at home. Among those who commuted to work, it took them on average 21.6 minutes to get to work.

INCOME: The median income of households in Little Valley town was \$41,653. Seventy-one percent of the households received earnings and 29 percent received retirement income other than Social Security. Forty-four percent of the households received Social Security. The average income from Social Security was \$14,769. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2005-2009, 9 percent of people were in poverty. Thirteen percent of related children under 18 were below the poverty level, compared with 7 percent of people 65 years old and over. Six percent of all families and 27 percent of families with a female householder and no husband present had incomes below the poverty level.





POPULATION OF Little Valley town: In 2005-2009, Little Valley town had a total population of 1,700 - 860 (50 percent) females and 840 (50 percent) males. The median age was 45.9 years. Eighteen percent of the population was under 18 years and 20 percent was 65 years and older.


The Age Distribution of People in Little Valley town, Cattaraugus County, New York in 2005-2009

For people reporting one race alone, 97 percent was White; 2 percent was Black or African American; less than 0.5 percent was American Indian and Alaska Native; less than 0.5 percent was Asian; less than 0.5 percent was Native Hawaiian and Other Pacific Islander, and less than 0.5 percent was Some other race. One percent reported Two or more races. One percent of the people in Little Valley town was Hispanic. Ninety-six percent of the people in Little Valley town was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Little Valley town had a total of 850 housing units, 13 percent of which were vacant. Of the total housing units, 76 percent was in single-unit structures, 19 percent was in multi-unit structures, and 5 percent was mobile homes. Fifteen percent of the housing units were built since 1990.



The Types of Housing Units in Little Valley town, Cattaraugus County, New York in 2005-2009



OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Little Valley town had 740 occupied housing units - 520 (70 percent) owner occupied and 220 (30 percent) renter occupied. Two percent of the households did not have telephone service and 10 percent of the households did not have access to a car, truck, or van for private use. Thirty percent had two vehicles and another 16 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$992, nonmortgaged owners \$402, and renters \$548. Twenty-seven percent of owners with mortgages, 11 percent of owners without mortgages, and 25 percent of renters in Little Valley town spent 30 percent or more of household income on housing.
