
NOTE. Although the American Community Survey (ACS) produces population, demographic and housing unit estimates, it is the Census Bureau's Population Estimates Program that produces and disseminates the official estimates of the population for the nation, states, counties, cities and towns and estimates of housing units for states and counties.

HOUSEHOLDS AND FAMILIES: In 2005-2009 there were 450 households in Little Valley village. The average household size was 2.1 people.

Families made up 57 percent of the households in Little Valley village. This figure includes both married-couple families (38 percent) and other families (19 percent). Nonfamily households made up 43 percent of all households in Little Valley village. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.


NATIVITY AND LANGUAGE: One percent of the people living in Little Valley village in 2005-2009 were foreign born. Ninety-nine percent was native, including 80 percent who were born in New York.

Among people at least five years old living in Little Valley village in 2005-2009, 2 percent spoke a language other than English at home. Of those speaking a language other than English at home, 33 percent spoke Spanish and 67 percent spoke some other language; 33 percent reported that they did not speak English "very well."

GEOGRAPHIC MOBILITY: In 2005-2009, 72 percent of the people at least one year old living in Little Valley village were living in the same residence one year earlier; 16 percent had moved during the past year from another residence in the same county, 7 percent from another county in the same state, 4 percent from another state, and less than 0.5 percent from abroad.



EDUCATION: In 2005-2009, 85 percent of people 25 years and over had at least graduated from high school and 6 percent had a bachelor's degree or higher. Fifteen percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Little Valley village was 220 in 2005-2009. Nursery school and kindergarten enrollment was 29 and elementary or high school enrollment was 140 children. College or graduate school enrollment was 52.

The Educational Attainment of People in Little Valley village, New York in 2005-2009






DISABILITY: In Little Valley village, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2005-2009, for the employed population 16 years and older, the leading industries in Little Valley village were Educational services, and health care, and social assistance, 18 percent, and Manufacturing, 16 percent.


OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Sales and office occupations, 23 percent; Service occupations, 23 percent; Management, professional, and related occupations, 18 percent; Construction, extraction, maintenance, and repair occupations, 18 percent; and Production, transportation, and material moving occupations, 18 percent. Seventy percent of the people employed were Private wage and salary workers; 24 percent was Federal, state, or local government workers; and 6 percent was Self-employed in own not incorporated business workers.

TRAVEL TO WORK: Eighty-five percent of Little Valley village workers drove to work alone in 2005-2009, 9 percent carpooled, less than 0.5 percent took public transportation, and 4 percent used other means. The remaining 2 percent worked at home. Among those who commuted to work, it took them on average 23.1 minutes to get to work.

INCOME: The median income of households in Little Valley village was \$36,141. Sixty-nine percent of the households received earnings and 23 percent received retirement income other than Social Security. Forty-one percent of the households received Social Security. The average income from Social Security was \$13,844. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2005-2009, 13 percent of people were in poverty. Nineteen percent of related children under 18 were below the poverty level, compared with 9 percent of people 65 years old and over. Eleven percent of all families and 31 percent of families with a female householder and no husband present had incomes below the poverty level.

Poverty Rates in Little Valley village, New York in 2005-2009



POPULATION OF Little Valley village: In 2005-2009, Little Valley village had a total population of 1,100 - 530 (49 percent) females and 540 (51 percent) males. The median age was 38.6 years. Twenty-one percent of the population was under 18 years and 17 percent was 65 years and older.

The Age Distribution of People in Little Valley village, New York in 2005-2009







For people reporting one race alone, 96 percent was White; 3 percent was Black or African American; less than 0.5 percent was American Indian and Alaska Native; less than 0.5 percent was Asian; less than 0.5 percent was Native Hawaiian and Other Pacific Islander, and less than 0.5 percent was Some other race. Less than 0.5 percent reported Two or more races. One percent of the people in Little Valley village was Hispanic. Ninety-five percent of the people in Little Valley village was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Little Valley village had a total of 480 housing units, 6 percent of which were vacant. Of the total housing units, 66 percent was in single-unit structures, 32 percent was in multi-unit structures, and 1 percent was mobile homes. Eleven percent of the housing units were built since 1990.

OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Little Valley village had 450 occupied housing units - 270 (59 percent) owner occupied and 180 (41 percent) renter occupied. Three percent of the households did not have telephone service and 14 percent of the households did not have access to a car, truck, or van for private use. Twenty-five percent had two vehicles and another 8 percent had three or more.


HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$896, nonmortgaged owners \$372, and renters \$534. Twenty-two percent of owners with mortgages, 13 percent of owners without mortgages, and 29 percent of renters in Little Valley village spent 30 percent or more of household income on housing.
