

NOTE. HOUSEHOLDS AND FAMILIES: In 2005-2009 there were 220 households in Lyndon town. The average household size was 2.5 people.

Families made up 75 percent of the households in Lyndon town. This figure includes both marriedcouple families (73 percent) and other families (1 percent). Nonfamily households made up 25 percent of all households in Lyndon town. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.



The Types of Households in Lyndon town, Cattaraugus County, New York in 2005-2009



NATIVITY AND LANGUAGE: Five percent of the people living in Lyndon town in 2005-2009 were foreign born. Ninety-five percent was native, including 84 percent who were born in New York.

Among people at least five years old living in Lyndon town in 2005-2009, 6 percent spoke a language other than English at home. Of those speaking a language other than English at home, 67 percent spoke Spanish and 33 percent spoke some other language; 58 percent reported that they did not speak English "very well."

GEOGRAPHIC MOBILITY: In 2005-2009, 91 percent of the people at least one year old living in Lyndon town were living in the same residence one year earlier; less than 0.5 percent had moved during the past year from another residence in the same county, 9 percent from another county in the same state, less than 0.5 percent from another state, and less than 0.5 percent from abroad.

Geographic Mobility of Residents of Lyndon town, Cattaraugus County, New York in 2005-2009



EDUCATION: In 2005-2009, 81 percent of people 25 years and over had at least graduated from high school and 10 percent had a bachelor's degree or higher. Nineteen percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Lyndon town was 85 in 2005-2009. Nursery school and kindergarten enrollment was 10 and elementary or high school enrollment was 56 children. College or graduate school enrollment was 19.

The Educational Attainment of People in Lyndon town, Cattaraugus County, New York in 2005-2009




Percent of people 25 years and over



DISABILITY: In Lyndon town, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2005-2009, for the employed population 16 years and older, the leading industries in Lyndon town were Agriculture, forestry, fishing and hunting, and mining, 23 percent, and Educational services, and health care, and social assistance, 21 percent.


OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Management, professional, and related occupations, 26 percent; Service occupations, 24 percent; Farming, fishing, and forestry occupations, 18 percent; Sales and office occupations, 17 percent; and Construction, extraction, maintenance, and repair occupations, 7 percent. Sixty-eight percent of the people employed were Private wage and salary workers; 18 percent was Federal, state, or local government workers; and 9 percent was Self-employed in own not incorporated business workers.

TRAVEL TO WORK: Fifty-seven percent of Lyndon town workers drove to work alone in 2005-2009, 13 percent carpooled, 4 percent took public transportation, and 2 percent used other means. The remaining 24 percent worked at home. Among those who commuted to work, it took them on average 31 minutes to get to work.

INCOME: The median income of households in Lyndon town was \$53,750. Sixty-four percent of the households received earnings and 34 percent received retirement income other than Social Security. Thirty-seven percent of the households received Social Security. The average income from Social Security was \$19,133. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2005-2009, 11 percent of people were in poverty. Twelve percent of related children under 18 were below the poverty level, compared with 8 percent of people 65 years old and over. Four percent of all families and 100 percent of families with a female householder and no husband present had incomes below the poverty level.


Poverty Rates in Lyndon town, Cattaraugus County, New York in 2005-2009

POPULATION OF Lyndon town: In 2005-2009, Lyndon town had a total population of 550 - 260 (48 percent) females and 290 (52 percent) males. The median age was 44.1 years. Seventeen percent of the population was under 18 years and 20 percent was 65 years and older.


The Age Distribution of People in Lyndon town, Cattaraugus County, New York in 2005-2009

For people reporting one race alone, 98 percent was White; less than 0.5 percent was Black or African American; 2 percent was American Indian and Alaska Native; less than 0.5 percent was Asian; less than 0.5 percent was Native Hawaiian and Other Pacific Islander, and less than 0.5 percent was Some other race. Less than 0.5 percent reported Two or more races. Four percent of the people in Lyndon town was Hispanic. Ninety-four percent of the people in Lyndon town was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Lyndon town had a total of 570 housing units, 62 percent of which were vacant. Of the total housing units, 82 percent was in single-unit structures, 1 percent was in multi-unit structures, and 17 percent was mobile homes. Forty-three percent of the housing units were built since 1990.




The Types of Housing Units in Lyndon town, Cattaraugus County, New York in 2005-2009

OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Lyndon town had 220 occupied housing units - 190 (89 percent) owner occupied and 24 (11 percent) renter occupied. Seven percent of the households did not have telephone service and 4 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Forty-six percent had two vehicles and another 22 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$1,190, nonmortgaged owners \$464, and renters \$1,153. Thirty-two percent of owners with mortgages, 13 percent of owners without mortgages, and 53 percent of renters in Lyndon town spent 30 percent or more of household income on housing.
