
NOTE. HOUSEHOLDS AND FAMILIES: In 2005-2009 there were 6,500 households in Olean city. The average household size was 2.2 people.

Families made up 58 percent of the households in Olean city. This figure includes both married-couple families (38 percent) and other families (19 percent). Nonfamily households made up 42 percent of all households in Olean city. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.

NATIVITY AND LANGUAGE: Two percent of the people living in Olean city in 2005-2009 were foreign born. Ninety-eight percent was native, including 79 percent who were born in New York.


Among people at least five years old living in Olean city in 2005-2009, 3 percent spoke a language other than English at home. Of those speaking a language other than English at home, 44 percent spoke Spanish and 56 percent spoke some other language; 40 percent reported that they did not speak English "very well."

GEOGRAPHIC MOBILITY: In 2005-2009, 82 percent of the people at least one year old living in Olean city were living in the same residence one year earlier; 13 percent had moved during the past year from another residence in the same county, 2 percent from another county in the same state, 2 percent from another state, and 1 percent from abroad.



EDUCATION: In 2005-2009, 88 percent of people 25 years and over had at least graduated from high school and 24 percent had a bachelor's degree or higher. Twelve percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Olean city was 3,400 in 2005-2009. Nursery school and kindergarten enrollment was 670 and elementary or high school enrollment was 2,000 children. College or graduate school enrollment was 800.

The Educational Attainment of People in Olean city, New York in 2005-2009




DISABILITY: In Olean city, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2005-2009, for the employed population 16 years and older, the leading industries in Olean city were Educational services, and health care, and social assistance, 32 percent, and Manufacturing, 17 percent.


OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Management, professional, and related occupations, 35 percent; Sales and office occupations, 28 percent; Service occupations, 18 percent; Production, transportation, and material moving occupations, 14 percent; and Construction, extraction, maintenance, and repair occupations, 5 percent. Seventy-seven percent of the people employed were Private wage and salary workers; 19 percent was Federal, state, or local government workers; and 4 percent was Self-employed in own not incorporated business workers.

TRAVEL TO WORK: Seventy-six percent of Olean city workers drove to work alone in 2005-2009, 10 percent carpooled, 1 percent took public transportation, and 11 percent used other means. The remaining 2 percent worked at home. Among those who commuted to work, it took them on average 16 minutes to get to work.

INCOME: The median income of households in Olean city was \$36,312. Seventy-one percent of the households received earnings and 22 percent received retirement income other than Social Security. Thirty-four percent of the households received Social Security. The average income from Social Security was \$14,120. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2005-2009, 19 percent of people were in poverty. Thirty-one percent of related children under 18 were below the poverty level, compared with 12 percent of people 65 years old and over. Seventeen percent of all families and 39 percent of families with a female householder and no husband present had incomes below the poverty level.


Percent below poverty level

POPULATION OF Olean city: In 2005-2009, Olean city had a total population of 14,000 - 7,400 (52 percent) females and 6,900 (48 percent) males. The median age was 40 years. Twenty-three percent of the population was under 18 years and 17 percent was 65 years and older.

The Age Distribution of People in Olean city, New York in 2005-2009







For people reporting one race alone, 92 percent was White; 4 percent was Black or African American; less than 0.5 percent was American Indian and Alaska Native; 1 percent was Asian; less than 0.5 percent was Native Hawaiian and Other Pacific Islander, and less than 0.5 percent was Some other race. Two percent reported Two or more races. One percent of the people in Olean city was Hispanic. Ninety-one percent of the people in Olean city was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Olean city had a total of 7,300 housing units, 11 percent of which were vacant. Of the total housing units, 67 percent was in single-unit structures, 33 percent was in multi-unit structures, and 1 percent was mobile homes. Five percent of the housing units were built since 1990.

The Types of Housing Units in Olean city, New York in 2005-2009







OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Olean city had 6,500 occupied housing units - 3,700 (58 percent) owner occupied and 2,700 (42 percent) renter occupied. Eight percent of the households did not have telephone service and 14 percent of the households did not have access to a car, truck, or van for private use. Twenty-eight percent had two vehicles and another 9 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$956, nonmortgaged owners \$475, and renters \$586. Twenty-four percent of owners with mortgages, 19 percent of owners without mortgages, and 58 percent of renters in Olean city spent 30 percent or more of household income on housing.
